Did you know? Three New Mexico governors: are buried at Fairview: William T. Thornton (1893-1897); Miguel Antonio Otero (1897-1906); Arthur Seligman (1931-1933) and acting governor Dr. Benjamin Morris Thomas (1889). [Thomas is the great-grandfather of FCPA board

With help from a special fund-raising letter, the FCPA received about half the estimated \$60,000 needed to build a concrete wall, extending four feet below ground and three feet above, along the western border of the cemetery. The picture to the left shows a portion of the fence that will be replaced in an attempt to stop the extensive damage that prairie dogs are doing to the cemetery. It is hoped that once new prairie dogs are prevented from migrating into the cemetery, the existing animals can be removed and we'll finally have a solution to this ongoing problem. Donations to the barrier wall are still being sought. (See page 3 of this newsletter). The more money that comes in for the barrier fund, the less will have to be taken from our savings. History at Fairview

Fairview's "residents" 100 years ago, from the *Santa Fe New Mexican*

Jan. 13, 1912; Otis Seligman [dc March 1943 at age 45, the son of Gov. Arthur Seligman dc 1933 at age 62] assisted by John K.S. Walter [dc 1987 at age 89], has manufactured an aeroplane of the glider type and the two boys yesterday tried out the machine successfully. It is large and strong enough to carry one of the boys. The flying machine was on exhibition yesterday to the envy and marvel of other boys. [There are 3 generations of Seligmans and 3 generations of the Walter family buried at Fairview. Descendants of both families are members of the FCPA..]

Feb. 12, 1912: Angus MacGillivray [dc 1917 at age 61] is erecting a 12-room bungalow in Santa Fe. It will be ready for occupancy about the first of April. The cost of his residence will be about \$12,000. August Reingardt [dc 1937 at age 84] is the contractor and builder.

NOTE: The "bungalow" still stands as the "Victorian" at 644 Don Gaspar, now the law offices of the Berardinelli family. Fairview Board of Directors member Lucy Dix comments: "Angus was my grandfather and the woman he married, **Julia Ethel Easley** [dc 1915 at age 32] was a musician. Angus built her a ballroom on the top floor so that she could play the piano and people could dance. The amount of money for the home was quite a lot for the year 1912."

Feb. 19, 1912: The confirmation of William H. Pope [dc 1916 at age 46] as U.S. district judge for New Mexico was recommended by the Senate Committee.... Judge Pope was on the bench in the Philippines when President Taft was governor general of the islands and later served as judge and chief justice of New Mexico. The contest over the office brought out numerous charges that the committee investigated, all of them of a flimsy nature.

Burials and Markers

While there have been no recent burials at Fairview, the Association is making progress in identifying, and possibly acquiring, hundreds of plots that may be available for sale at some point in the future. We hope to have more information on this project in time for the fall newsletter.

An estimated 1,500 of the 3,500 graves at Fairview remain unmarked. Unfortunately, the monument company through which the Association obtained a small discount for markers has closed its doors, and a new resource has not been located. Both flat and upright headstones are allowed at Fairview
