

JOHN ADAMS, NEW PRESIDENT

In our last newsletter we told you how pleased we were to have the newly dedicated information pavilion finished. All that remained was to have a map display installed and a directory of burial locations. Those of you who went to the Spring Clean-up saw the finished project and it has served us well in our first full

summer season. We want to thank NM Office Solutions and Technigraph for their contributions.

Doesn't Fairview look better than it has in years? Guy Gray, our contract caretaker, has done a great job of getting things up to par. This level of maintenance still leaves some things to be desired but it goes to show what can be accomplished by people who are performing a labor of love.

Our first full year of operation has had some challenges, though. We have had difficulties with collecting rent and with water bills, indicating a need to conserve. We are now in the process of looking for a tenant for the former caretaker's house. It is 1300 sq. ft. with two bedrooms and one bath. Someone who enjoys the quiet and security of the location may want the house as a residence or it could be used as a professional or small organization office. We asked Sangre de Cristo Water Company to do an audit of our water usage so that we could see how we

compared to similar facilities. We learned that parts of the first system we installed about 15 years ago need to be updated and improved. We also are watching the meter readings to compare with our bills after reports in the press of inconsistencies.

Another challenge facing us is the decline in donations. I have asked the treasurer, Doug Thayer, to put regular reports of our financial condition in the newsletter. We are also taking steps to look for more ways of raising money.

Advertising in the newsletter is one way—we hope to partially offset the 50 cent per person cost so that we may communicate with our supporters more frequently. We also have begun to explore sources of grants and other forms of corporate support.

Your Board of Directors is working to find ways of cutting expenses. We have begun a revision of our bylaws to bring them into line with our position as owners of the cemetery. We have established an internet community

to let the world know of this significant historical resource and the challenges we face. A telephone answer service provides consistent communication facilities. (505-989-1623).

But much work remains to be done. We need to look at long range solutions to the way we are organized. If we cannot develop committees with people with strong business experience to guide us into the future we need to look for ways in which we can assist some organization in filling this function for us.

Volunteers are needed to develop our business plan and to put together a major fund-raising project. My estimate is that we need to establish a \$1 million endowment fund to be able to preserve Fairview indefinitely. If our resources keep declining we will just have to do the best we can. I am afraid that much of the progress made this year will be lost.

I know that some methods of raising money are distasteful to some of our supporters. If you have concerns or suggestions as to things we might try please share your thoughts with me—982-1904.

OFFICERS AND DIRECTORS ELECTED

At the Spring Clean-up and luncheon, John Adams was elected our new president. John's late aunt and uncle, Mamie and Burton Dwyre, are buried at Fairview. But another link for John to Fairview is the Masonic Order. John probably is familiar with the name of every Mason who is buried there, and there are a lot.

First Vice President is Simon Peter Bickley, whose parents and son are buried at Fairview. grandfather, B. F. Young, is also there. donated the land on which B. F. Young was built some thirty years ago. Reelected were Marian Meyer, 2nd Vice President, Catherine Thayer, Secretary, and Doug Thayer, Treasurer. Directors who still have a vear to serve on their terms are: Ronald Ball, Bob Lawrence, and Kathy Roberts. Re-elected was Marian Karlson, New Directors are Margaret Brunk, Bob Clifford, Bradley Morris Thomas, and Joan Stotts. Margaret's husband and other family members are tenants of Fairview, as are Brad's parents and grandparents. Bob Clifford and Joan Stotts both served stints on the board over a decade ago. Joni's two Fiske children are sixth generation Santa Feans. They have 16 relatives at Fairview. Thanks to all of the directors for accepting this responsibility.

A LOOK AT OUR FIRST YEAR

We knew this going in, but owning the cemetery is far more difficult than just helping to maintain it. However, we now have full say in how we manage it, which makes for less frustration. Our biggest single concern is paying the bills. We now have a great deal more we are responsible for, including the sometimes-staggering water bill. In an attempt to keep the cost down, in the spring our caretaker was instructed to keep the cemetery green, but not lush. Fortunately, we have had a good deal of rain and that has kept the grass beautiful most of the summer. We are less than a month away from turning the water off, so that bill will go down.

A new but important expense is SECURITY. We have AKAL to open the gates at dawn, close them at dusk, and check from time to time. Guy Gray, our contract caretaker, is paid by the month, and is probably the most important expense we have, but worth every cent of it. The best part is that we no longer have to buy tractors, weed whackers, and the many things which keep Fairview beautiful. Guy has a really fine tractor mower, similar to our old Grasshopper, which will turn on a dime, and takes the uneven terrain so much better than some of our old inexpensive mowers (remember when our Association had a special fund drive to buy the Grasshopper? It cost \$6000 and was President Gil Fincke's pride and joy. When our fund drive reached \$3000, generous Sunwest Bank pitched in the other \$3000!). Another really wonderful thing is not having to worry about repairs to the mower. Sometimes the mower would be down for weeks at a time, waiting for parts and repair.

Renting out the caretaker's house for income is not one of our favorite aspects of ownership of Fairview. The year lease has just run out and we will be looking for a reliable tenant as soon as we get the house fixed up. That will cost us a good deal more than the deposit we got. Live and learn. The house is more

than a century old, but is in surprisingly good condition, structurally. It is 2 bedrooms, 1 bath, large living room, kitchen and small laundry room. The rent is \$700 per month, first and last month's rent and a damage deposit, plus utilities. If you know of a possible renter, call Brad Thomas, 984-1188 or Joan Stotts, 471-8014.

We did not have many burials last year and all of them were ashes except one. This year starting in June, there four full burials in a row. HARRY LONG BIGBEE, longtime local attorney, former judge and a prominent Santa Fe citizen, was buried next to his wife, Betty.****ALTAGRACIA Ortiz, who would have turned 108 in September, was buried with a good deal of fanfare. Her family released 108 balloons-it was joyous and colorful indeed.****SAM THORNBURG died following an extended illness. His work took him and his family to many countries over the years, but he and his wife Ann came back to Santa Fe to retire. He is buried just down the road from the rest of the Thornburg family,****CAMELLIA BOWLDS, a dear sweet lady and a friend of Marian's for 20 years, would not have been surprised that we couldn't find room for her in the family plot. She and Marian met more than once at Fairview to ponder the problem because it just didn't look like there was enough space. We were right. When the Woman's Club buried two other relatives, they encroached on the third grave. There was not even half a space left. It was necessary to dis-inter Clarence and do a double interment for the two of them. Rest in Peace. Camellia.***The ashes of SIMON PETER BICKLEY III, who died a few years ago, were interred in the grave of his grandparents. Our condolences to all the families.

FCPA Finances by Doug Thayer, Treasurer

It has been over a year since the Association assumed ownership of Fairview Cemetery and made the transition from a support organization to full management of the cemetery. In the past 14 months the Board has learned a lot about the fiscal realities of operation as we have proceeded with daily upkeep as well as needed improvements. In the next few paragraphs I will relate some of the information we have gained, and the challenges we face as we proceed into our second year of ownership of this unique cemetery.

Our total operating expenses for the 14-month period were \$46,500 (including the construction of the much needed information pavilion, \$9,900). As expected, the cemetery grounds were our largest expense category during this time, for a total of almost \$27000 (water, \$13,600, maintenance, \$13,400).

Our income for the period was approximately \$63,200, including \$18,000 as a one-time contribution from Santa Fe County and \$18,000 in grave plot sales. Other items included \$7,600 from rental of the caretaker's house, \$5,400 from the Womans Club Trust, and \$12,000 in contributions. As you can see, your contributions are extremely important to the continued operation of the cemetery!

While the above figures show a rough balance between income and expenditures over the past 14 months, they do not really show the challenges facing the Board. Removing the cost of the information pavilion shows an annualized operating expense of approximately \$32,000. Removing the grave plot sales and the County's one-time contribution shows an annual income of \$27,200 — a shortfall of \$4,800 per year, assuming that contributions continue as in the past!

One of the Board's challenges (in addition to meeting annual expenses) is to increase the Cemetery's endowment in order to decrease dependence on annual contributions in the future. Allocating proceeds of grave plot sales to the endowment will help, but more needs to be done. Please consider additional gifts earmarked for this purpose, as well as continuing the vital contributions so necessary for annual expenses!

AN EARLY SANTA FE BRIDE: ESTHER THOMAS

Esther Thomas came west on her wedding trip, following a three year engagement. Her courtship by Dr. Benjamin Morris Thomas is partially revealed in two Victorian-era letters, part of the Thomas Collection at the Fra Angelico History Library. The year was 1868 when the young dentist sent a formal note to the Honorable James Bradley, father, of "Hetty," and a prominent judge in La Porte, Indiana. The message contained an earnest request:

"As I have formed an attachment for your daughter Hetty which I would be very sorry to have broken off, and as I have assurance from her that it need not be broken off, I ask for your permission to strengthen that attachment ad *infinitum* with the hope

of receiving your full and free consent.

He did not wait long for an answer. That very day Judge Bradley replied in a favorable but somewhat stiffer tone:


"Dear Sir: I have received yours of the 9th inst. The acquaintance I have hitherto had with you has enabled me to form a very favorable opinion of you as a Gentleman, and hence if the matter to which you allude has been well and maturely considered on both sides, I have no hesitation in giving it my full and free approval.."

Originally scheduled for June of 1870, the wedding had to be postponed when Thomas' health failed. He spent a healing year in Arizona, found employment with the Indian agency and returned to claim his bride in 1871. A helf-century later, Esther's obituary would note that she "braved all the hardships of the western life, became acquainted with the character of the Indian, and was of great assistance to her husband in making friends with their puzzling wards of the United States Government."

By 1874 Esther had set up housekeeping in Santa Fe where Thomas was agent to the Pueblo Indians. In 1889 he was appointed Territorial Secretary by President Benjamin Harrison. With Governor L. Bradford Prince out of the territory much of the time attending to his business and political connections in the East, Thomas frequently served as acting governor. He died 3 years later, leaving Esther to raise their only child, Bradley Morris, born in 1882. Young Thomas was a member of the first graduating class of Santa Fe High School in May 1900. Of those

first five graduates, descendants of only two remain in Santa Fe. Bradley Morris Thomas, Jr. and his sister, Virginia Thomas Nydes, are both active in business here.

The Woman's Board of Trade was founded in 1892, the same year Esther's husband died, but it wasn't until 1898 that she became a member-possibly because the group was actively seeking to acquire operation of Fairview Cemetery where her husband was buried.
